

Regulatory Reform Report: Completed Actions for Fiscal Year 2018

This chart provides a detailed list of each agency’s Executive Order 13771 deregulatory and regulatory actions completed in fiscal year 2018.

- 12 to 1: Agencies issued 176 deregulatory actions and 14 regulatory actions.
- 57 deregulatory actions were significant. Comparing significant deregulatory actions to significant regulatory actions yields a ratio of 4 to 1.
