

Regulatory Reform Report: Completed Actions for Fiscal Year 2020

This chart provides a detailed list of each agency's Executive Order 13771 deregulatory and regulatory actions completed in fiscal year 2020.

- 3.2 to 1: Agencies issued 145 deregulatory actions and 45 regulatory actions. (Under OMB guidance implementing EO 13771, this ratio is the relevant one for assessing compliance with the EO in 2020.)
- 58 deregulatory actions were significant. Comparing significant deregulatory actions to significant regulatory actions yields a ratio of 1.3 to 1.
